RESOLUTION OF THE CITY COUNCIL APPOINTING ANGEL JONES
AS CITY MANAGER FOR THE CITY OF GAITHERSBURG, MARYLAND
EFFECTIVE SEPTEMBER 29, 2008

WHEREAS, a vacancy existed in the position of City Manager for the City of Gaithersburg, Maryland, due to the retirement of the City Manager, effective October 28, 2007; and

WHEREAS, Section 18 of the Charter of the City of Gaithersburg specifies that in the event of the suspension, removal, resignation or death of the City Manager, the Council may by resolution, designate an officer of the City as Acting City Manager to perform the duties of the City Manager for such period as may be necessary; and

WHEREAS, the Mayor and City Council of Gaithersburg had determined that it was in the best interest of the City to appoint James D. Arnoult as Acting City Manager for the City, effective October 29, 2007; and

WHEREAS, the Mayor and City Council conducted an exhaustive executive search to fill this pending vacancy, and in the course thereof, have reviewed, with the assistance of a professional consultant, the qualifications of numerous applicants; and

WHEREAS, the Mayor and City Council believe that Angel Jones possesses the requisite qualifications and intimate knowledge of the workings of City government, and the functions and demands of the position of City Manager:

NOW THEREFORE, BE IT RESOLVED, by the City Council of Gaithersburg, that Angel Jones be and she hereby is appointed to the position of City Manager to perform the duties of the City Manager pursuant to Section 18 of the City Charter, effective September 29, 2008.

AND, BE IT FURTHER RESOLVED, that Angel Jones is hereby designated in accordance with Section 46 of the City Charter to countersign all checks issued in payment of City obligations while performing the duties of City Manager.
