

ORDINANCE NO. O-7-08

AN ORDINANCE TO AMEND CHAPTER 24 OF THE CITY CODE (CITY ZONING ORDINANCE), ARTICLE XVI, ENTITLED "AFFORDABLE HOUSING REQUIREMENTS" §24-255 ENTITLED "AFFORDABLE HOUSING REQUIREMENTS FOR DEVELOPMENTS IN THE OLDE TOWNE CENTRAL BUSINESS DISTRICT," SO AS TO PRECLUDE THE APPLICATION OF THE AFFORDABLE HOUSING REQUIREMENTS TO ANY ENTERPRISE ZONE ESTABLISHED PURSUANT TO STATE LAW

BE IT ORDAINED, by the Mayor and City Council of the City of Gaithersburg, Maryland, in public meeting assembled that Chapter 24 of the City Code (City Zoning Ordinance), Article XVI, is amended as follows:

Section 24-255. Affordable housing requirements for developments in any enterprise zone established pursuant to State law.

The requirements of Section 24-252, 24-253, and Section 24-254 shall not apply to residential construction in any enterprise zone established pursuant to State law; however, developers shall be required to pay a per unit fee for each dwelling unit to a City affordable housing fund. This fee shall be determined by regulation pursuant to section 24-256 of this article.
