

ORDINANCE NO. O-2-14

AN ORDINANCE TO AMEND SECTIONS 7-1, ENTITLED "ADOPTION OF NATIONAL ELECTRICAL CODE", SECTION 7-2, ENTITLED "ENFORCEMENT" AND SECTION 7-14, ENTITLED "AMENDMENTS TO NATIONAL ELECTRICAL CODE" SO AS TO ADOPT THE 2011 NATIONAL ELECTRICAL CODE (NFPA 70)

BE IT ORDAINED by the Mayor and City Council of Gaithersburg, in public meeting assembled, that Chapter 7 of the City Code entitled, "Electricity" is amended to read as follows:

Chapter 7

ELECTRICITY

Sec. 7-1. Adoption of National Electrical Code.

The National Electrical Code, NFPA 70, 2011 Edition is hereby adopted and incorporated herein by reference and shall be the governing standard for all electrical work performed in the corporate limits of the City. When provisions of this article conflict with the provisions of the National Electrical Code, 2011 Edition, then the provisions of this article shall govern. Copies of the National Electrical Code, 2011 Edition, as adopted, shall be available for inspection by the public during regular City office hours.

Sec. 7-2. Enforcement.

Wherever the 2011 National Electrical Code uses the words "the authority having jurisdiction of enforcement of this Code," or words having a similar meaning, they shall be construed to mean the city manager or her designee.

Sec. 7-14. Amendments to National Electrical Code.

The National Electrical Code, 2011 Edition, is amended in the following respects:

(10) Table 310.106(A) is amended to read as follows:

At the end of the text, add the statement:
