The DeVol application was presented to the Mayor and City Council on August 3rd. Originally the Council closed the record on September 2, but on August 11th, the Applicant requested the Council to extend the record to allow time to conduct outreach with the community. The new record closing date is September 16th and the Council will make a final action on October 5th.

The Applicant is planning to have a virtual meeting on September 9th at 6:30pm to answer any questions that the community may have on the DeVol application.
